- Connector Link: 13,000 s.f. walkway link connecting the Ambulatory Care Center to existing campus buildings. Work includes lower level walkway tunnel, retail pharmacy and gift shop space. Project also includes a new kitchen and café space.
- **Campus Sitework:** 19 acres of sitework include additional parking, roadway reconfigurations, major utility upgrades and extensive landscaping.
- Emergency Department: Construction consists of 38,500 s.f. of emergency department addition and renovations spread over 6 phases of work. Improvements include 30 new treatment rooms, new x-ray rooms and a new ambulance bay. New triage, office and waiting spaces are also included. Basement under the addition houses all major mechanical components.
- **Radiology Expansion:** 24,800 s.f. of construction for the expansion and renovation of existing radiology space. Work included infilling space under the existing south tower as well as adding a 2<sup>nd</sup> floor for mechanical and future buildout needs. The new radiology space houses new MRI Rooms, a new Cath Lab and a new Interventional Radiology Room.
- **Central Plant:** Work includes a 5,000 s.f. addition to an existing plant. The new addition will accommodate diesel-powered emergency generators and switchgear including underground fuel storage tanks. The emergency generator upgrades will service the additional demands of the new Emergency and Radiology departments built under separate phases.
- **5<sup>th</sup> Floor Expansion:** Consists of adding a fifth floor to the patient tower. Work includes removal of existing roof and parapets, adding a new structural steel structure, precast and metal panel cladding, glazing and roofing. 37,100 s.f.

## 3<sup>rd</sup> Floor Surgery Expansion Provena Saint Joseph Medical Center

- Joliet, Illinois
- 9,000 s.f. building addition above the Hospital's occupied Labor & Delivery Department to create four (4) new Operating Rooms and General OR Support.
